

# **Certification Pathway/Assessment Guidelines**

## Level 4 Sea Kayak Instructorship Award

### Applying to attend an assessment.

Before applying to attend an assessment, a candidate must:

- 1. Have Maintained registration as a Level 4 Sea Kayak Instructor trainee.
- 2. Hold a Level 3 Kayak Instructor Qualification.
- 3. Hold the Canoeing Ireland Level 5 Sea Kayak Skills Award.
- 4. Be at least 18 years of age.
- 5. Have unrestricted access to a fully equipped Sea kayak, personal equipment and additional equipment as listed for a Level 3 Sea Kayak Instructor Assessment.
- 6. Have attended an approved Level 3 Sea Kayak Instructor Training Course or Programme within the 24 months period preceding a selected assessment date.
- 7. Possess a current and Canoeing Ireland approved First Aid Certificate (REC 3 or equivalent).
- 8. Have completed a Sport Ireland approved Child Protection Awareness Workshop.
- 9. Be a member of Canoeing Ireland.
- 10. Completed your garda vetting application.
- 11. Return a completed Level 3 Sea Instructor Logbook, with all the above pre assessment requirements fully detailed, to the Canoeing Ireland office no later than three weeks prior to the assessment date.

### **Other logbook requirements:**

The logbook should reflect a wide range of sea kayaking experience during the training. details of activities prior to applying for the Sea Instructor Training Course should also be recorded.

- 1. Recorded in a Level 4 Sea Kayak Instructor Logbook, following the completion of a Level 4 Sea Kayak Instructor Training Course at least 25 hours of instructional experience on the sea in moving water conditions under the supervision of at least two registered Level 4 Sea Kayak Instructors.
- 2. Recorded as part of the 25 hours supervised instructional experience, on at least three different sea trips, details of assisting in the preparation of a group for a Level 4 Sea Kayak Skills Assessment. This group must consist of at least three participants.
- 3. Assist on two Level 4 Sea Kayak Skills Assessments.
- 4. Attend two Level 4 Sea Kayak Skills Training Courses





- 5. Assist on two Advanced Coastal Navigation Courses.
- 6. Participate in three Irish Canoeing Competitions or hold a Level 4 Skills Award in another discipline.
- 7. Be recommended for assessment by a registered Level 4 Sea Instructor.

#### Format of a Level 4 Sea Kayak Instructor Assessment

The Level 4 Sea Kayak Instructor Assessment will take place over one day and must include a sea trip in slight/moderate sea conditions over a minimum distance of 4-8 kilometres .

#### A candidate will be expected to:

- 1. Organise and lead an instructional session for intermediates over the course of a coastal sea trip.
- 2. Teach any stroke, technique or rescue applicable to water up to and including smooth seas as outlined in the Level 4 Sea Kayak Skills Award.
- 3. Demonstrate effective group control, group rapport, and instructional ability.
- 4. Demonstrate an ability to carry out the following rescues efficiently and effectively in slight/moderate sea conditions. Self-Rescue, X and/or Assisted -X Rescue, All-in-Rescue, Unconscious Casualty, and Eskimo Rescue.
- 5. Demonstrate an ability to roll competently in moving water without any prior set-up.
- 6. Demonstrate all techniques and skills as required by Level 4 Sea Skills Award.
- 7. Demonstrate a thorough knowledge of First Aid in the sea kayaking environment as well as a thorough working knowledge of the cause/effect/treatment of Shock, Hypothermia, EAR, CPR, and the treatment of an unconscious casualty.
- 8. Have maintained a skills level equivalent to that of the Level 5 Sea Kayak Skills award.
- 9. Possess a sea kayak correctly fitted out for instruction and other appropriate personal equipment (See Sea Instructor List of Equipment). It would be expected that a candidate's equipment would be of a standard consistent with the responsibilities likely to be encountered by a Sea Instructor. Examination of equipment will form part of the overall assessment.
- 10. Before setting off on the assessment trip the candidate will be required to produce a route summary for the day based on information gleaned from the chart, tide tables, pilot, and weather forecast. Participants may also be asked to complete a route plan for an area other than the assessment area.
- 11. Answer questions written or oral, on aspects of sea kayaking covered during the training course or in the support literature.
- 12. Attend a debrief with the Assessor.

#### Assessment Guidelines





- It is recommended that Instructors other than the Instructor who has run the training course leading to the assessment assess a Level 4 Sea Kayak Instructor Qualification. Notwithstanding this, a Level 4 Sea Kayak Instructor Qualification can only be assessed by members of the Level 4 Kayak Instructor Assessor Panel
- Clear guidelines should be given in writing should a candidate fail an assessment as to the areas that need to be improved on.
- Candidates cannot depend on any assistance (material or practical) during an assessment.
- No other award may be assessed at the same time as the Level 4 Sea Kayak Instructor Qualification.
- The candidate/assessor ratio should be a maximum of 4:2.
- A Level 4 Kayak Instructor Assessment must be assessed by a minimum of two members of the Level 4 Kayak Instructor Assessor Panel.
