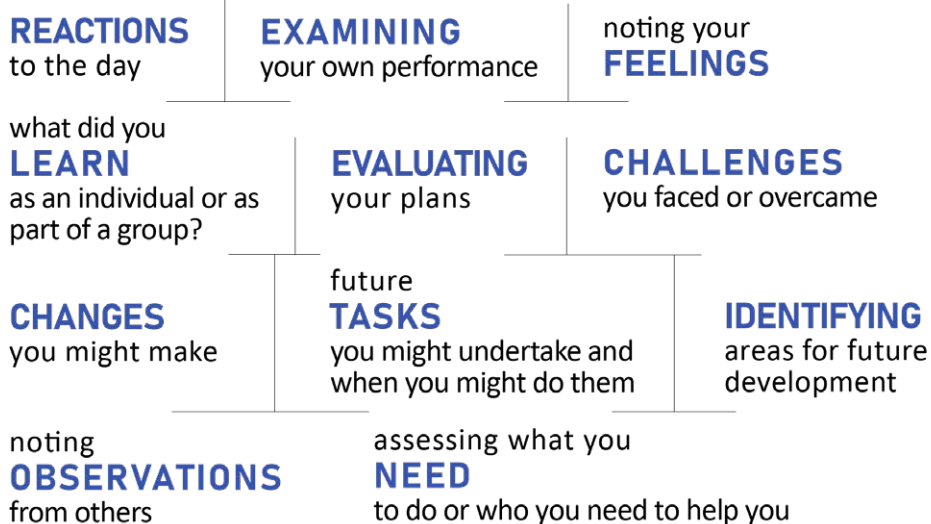

HOW TO COMPLETE YOUR PADDLER PROFILE.

Welcome to your Canoeing Ireland Paddler Profile. This book provides a record of your progression and Certification along your Sea Kayak Skills Awards pathway.

1. The sea kayak skills in each award are grouped into different modules, each with their own learning outcomes. Completion of these outcomes must be signed off in the Skills Checklists Section of your Profile, by a registered, qualified Canoeing Ireland sea kayak instructor to verify that you have met the required standard. You can work on the modules in any order you wish.
2. Once you have completed the learning outcomes for all modules in the award you must get a qualified, Canoeing Ireland registered sea kayak instructor to sign the Certification Section and they will then process the relevant sea kayak skills award certificate for you.
3. At the end of each award there is a section for you to note down ideas and plans for your future development as a paddler.
4. You may choose to train and do a one-off assessment for each award or you may complete modules over time at your own pace. Once all modules are signed off, and the certification section completed, you have attained the award.
5. At Sea Kayak Level 2, Peer Award and higher, there is space for your instructor to provide feedback on your progress in each module. In the Reflection Page you are encouraged to reflect on your paddling pathway, and to engage with instructors, coaches and other paddlers to help guide and refine your progression.

SEA KAYAK LEVEL 2. PEER AWARD.

EXPECTATIONS

I can control a kayak and confidently paddle with peers in Level 2 conditions. I am also capable of joining more experienced kayakers on a trip led by certified leaders or instructors. I can work with others to perform an assisted rescue as a swimmer and as a rescuer. I have a fundamental understanding of weather, tides and have been introduced to basic navigation skills. I know methods for summoning outside rescue assistance. I understand how to reduce my impact on the environment and wildlife while sea-kayaking. I can identify the next step involved in the Canoeing Ireland Sea Kayak Skills Awards.

CONDITIONS

COASTAL FEATURES Coastal areas with a minimum of marine traffic and where there is minimal possibility of being blown or drifting offshore. Launching and landing from/at a public access location such as a short section of beach/slipway/pier with easy landing - no tide races, overfalls, surf or swell. Journeys should, at any time, be no greater than 1 nautical mile to an exit point in case of emergency.

WIND (BEAUFORT) F0-3

SEA STATE (MET ÉIREANN) Smooth (0.1 - 0.5m significant wave height)

SURF N/A

FLOW No tide races, overfalls, surf or swell

OPEN CROSSINGS N/A

CRAFT A seaworthy sit-in sea kayak of adequate buoyancy, fitted with fore and aft toggles, deck lines (perimeter lines) fore and aft, with a minimum of two bulkheads and two hatches. Skogs and rudders are acceptable when used appropriately.



TRAINING, ASSESSMENT, CERTIFICATION

TRAINING COURSE ENTRY REQUIREMENTS	Sea Kayak Level 1. Discovery Award skills standard. No age restriction. Obtain a Canoeing Ireland Sea Kayak L2 Peer Award Paddler Profile from the Canoeing Ireland website at canoe.ie or their instructor.
DURATION OF TRAINING COURSE (INDICATIVE GUIDELINES)	Recommended 21 to 28 hours contact time with a qualified instructor.
ASSESSMENT	<p>Paddlers can choose a single one-day assessment, or a progressive sign off of modules in their Paddler Profile over time. Assessments do not have binary pass/fail outcomes, the instructor/s sign off the paddler's module/s where they have met the required standard, and provide feedback to the paddler on module/s where they are 'not there yet.'</p> <p>The sea kayaker will prepare a trip plan and then discuss it to allow the instructor to confirm that the sea kayaker's trip planning knowledge is at the required standard.</p> <p>The paddler is required to be able to demonstrate all knowledge and skills from lower levels and at a higher standard than that required for the preceding level.</p>
CERTIFICATION	When all the required L2 sections of your Canoeing Ireland Sea Kayak Paddler Profile have been signed off by your instructor/s, you must ask the final instructor to apply for certification. Canoeing Ireland then award the Sea Kayak Level 2. Peer Award Certificate to you. Sea Kayak Level 2 Peer Award holders under 18 years of age should be appropriately accompanied by a person who is over 18 and holds the Sea Kayak Level 2 Peer Award or higher. Please refer to your club or centre's guidelines regarding paddling with under 18s.

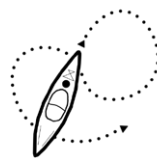

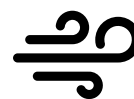

✓ I can interpret a basic marine weather forecast and apply this information to an O.S. map or marine chart. Indicate wind direction and strength, identify a lee and windward shore, identify areas of exposed shoreline where dynamic water may be challenging.

✓ I can explain the Beaufort scale up to Force 6 (inclusive).	
✓ I can use a tide table to obtain the times and heights of High and Low water and relate this information to my launching and landing area.	
✓ I can obtain information of tidal currents in my local area.	
✓ I can describe the effects of wind against tide and wind with tide on sea conditions.	
✓ I can interpret a basic swell forecast and explain the ramifications that the swell will have on my intended trip or session	
✓ I can plan a half day trip using an O.S. map or marine chart (electronic or hard copy) including start and finish positions, obvious waypoints along the way, escape/exit points and potential challenges which may be encountered on that trip.
