### About Canoeing Ireland – Equality, Diversity & Inclusion

### Introduction

This document lays out how Canoeing Ireland intends to adhere to standards of practice and policy in disability inclusion. It will begin with the role of the disability coordinator and staff, articulate Canoeing Ireland's vision and mission, and outline its statement of equality. The objectives will show how Canoeing Ireland is going to implement the disability inclusion policy into practice. Lastly, what Canoeing Ireland holds dear are its values and how they are at the forefront of all its practices.

### **Disability Coordinator**

Canoeing Ireland has staff in place to manage and coordinate developments in the Equality, Diversity & Inclusion department and to design and carry out programmes accessible for all. This includes working with Active Disability Ireland (ADI) to ensure opportunities for people with disabilities to participate in Paddlesports, as well as endeavour to meet the participant's needs.

Our mission is to increase participation in Paddlesports by improving accessibility and equivalence by reducing barriers to entry to Paddlesports as we recognise the value of participation at all levels and promote the sport in all its forms to everyone.

### **Statement of Equality**
